Know all by these present, that the undersigned hereby makes, constitutes and appoints Robert Hadfield, Kevin G. Lafond, Marc Recht, Joshua Rottner, Courtney T. Thorne, Christopher Gerry and Cameron Vermette as the undersigned's true and lawful attorneys-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:
